### Available Inground Pool Closing Services:

- \$395\* Full Closing:** winterize pool/spa plumbing and one filter system, includes cleaning DE or cartridge element, remove and store pool accessories on owners property, cover pool and secure. (Chemicals not included) Water tubes will be provided at Kasper's discretion @ \$7.99/ea. Assumes pool is clean and ready to be covered. **SEE ADDITIONAL CHARGES BELOW**
- \$295\* Winterize pool/spa plumbing and one filter system.** Same service as above EXCEPT Kasper's will NOT put on the pool cover.
- \$195\* Blow and plug lines only.** WATER LEVEL MUST BE BELOW SKIMMERS (or an extra charge will be billed) Filter system will be winterized/cleaned by customer. Cover may already be on pool.

- Any additional filters to be disassembled and cleaned will be separately charged **\$104** per filter.
- Any additional lines to be blown and plugged that have separate pumps (spa booster pump lines, waterfalls, etc) will be charged **\$62** per pump line circuit.
- Installing undercover padding for rough coping under safety covers will be charged **\$122**.
- Winterizing in-floor cleaning systems (Caretaker Systems) requires a **\$111** additional charge.
- Installing wall cables for safety covers requires a **\$68** additional charge.

### Available Aboveground Pool Closing Service:

- \$295 Full Closing**, less chemicals (winterize plumbing and filter system, clean DE and cartridge filter elements, remove accessories, store on owners property, cover pool and secure (Assumes pool is clean and ready to be covered)

### Portable Spa Closing Service:

- \$197** Drain and **Winterize Portable spa** plumbing and pump/filter system.
- \$295** Drain and **Winterize Swim spa** plumbing and pump/filter system.

### Winter Chemicals (Default: Add Winterizing Chemicals)

- Add Winterizing chemicals as determined by Kasper's technicians** (Retail Pricing)
- DO NOT ADD ANY CHEMICALS** (extensive spring cleanup may result by not adding winter chemicals)

### Other Services

- \$29** Pool skimming per quarter hour — includes pool surface and floor of most all leaves. Highly Recommended. If your pool is closed containing leaves, the water will likely turn green by spring, because of the decaying organic matter.
- \$52** Disconnect & Store Motor for winter
- \$79** Winterize Solar Panels

# Terms

1. Payment is due upon completion of autumn service. All accounts must be current at this time.
2. Kasper's Aqua Clear, Inc., herein after called "Kasper's", agrees to carry in full force and effect Public Liability and Property Damage insurance and Owners and Contractors Public Liability and Property Damage insurance in addition to the Workman's Compensation insurance required by law.
3. Kasper's shall not be held responsible for any damage to the pool, its decks or other related parts caused by hydrostatic pressure (water pressure) should it occur during the emptying of the pool for cleaning, painting, or repairing or while the pool is left empty or filling.
4. Kasper's shall not be held responsible for any damage to lawns, shrubbery, or landscaping caused by the discharge of water and its contents when emptying the pool for lowering the water level, or the backwashing or cleaning of the filter system.
5. Kasper's shall not be held responsible for damage to lawns, shrubbery, or landscaping caused by unrolling or cleaning the pool cover, or from any chemical residues on the cover.
6. Any service-related billing questions or errors must be filed within 10 days of the billing date, or invoice will be due in full.
7. Should payment on this account be in default, and should it be necessary for Kasper's to obtain legal representation and/or institute suit for collection, then Owners/Lessees agree to pay in addition to the amount due and owing, interest thereon at the rate of 18% per annum; and any and all reasonable attorneys fees and cost of suit.,
8. This agreement becomes valid upon Kasper's receipt of the original copy, properly signed by the owner/lessee, accompanied with the required remittance and accepted by Kasper's.
9. Work orders must be cancelled no later than 24 hours in advance of the scheduled closing date. Work not cancelled will be billed as a regular service call at prevailing rates. Cancellation # \_\_\_\_\_

## Guarantee

Should any defects arise in the filter system, pool recirculation lines, heater, pump unit (wet end only) or sanitizing system caused by Kasper's improper winterizing or usage of defective materials, then such defects will be repaired at no cost to the pool owner. This guarantee applies only if Kasper's performs winterization prior to any "hard freeze" which results in damage to previously noted pool components. Further, any such damage will be noted on the invoice covering winterization. Guarantee specifically does not include winter damage to the pool shell, decks, tile, coping, or spa type return jets. There is no guarantee against any kind of staining that occurs during the winterized season, because stagnant water is unpredictable. If the "blow and plug lines only" service is contracted, this guarantee extends to cover the pool recirculation lines only.
