Preseason and post season Services

Opening Vacuum Service: Sometimes debris in a swimming pool is beyond the ability of a standard residential filtration system or automatic cleaner. Choosing this option allows Kasper's to send a service technician 1-3 days after you pool is opened for a general cleaning and backwashing. Kaspers uses an independent vacuum system for large debris. This service does not guarantee, and the customer should not expect, perfectly clean swimmable pool water but rather it gets the pool to a condition that your residential filtration or automatic cleaner can handle.

Off Season Vacuum Service: Kaspers will maintain your pool weekly or biweekly before memorial day and after labor day. \$99.00/ weekly visit Plus Chemicals OR \$157.00/ biweekly visit plus

Chemicals

In Season Services: Memorial Day through Labor Day

In season services are performed after Memorial day and before Labor day holidays. In season rates apply.

Weekly Service: Kasper's will service your pool once a week on the scheduled day that we are in your area. **\$75.00/ visit + chemicals.**

OR

Bi-Weekly Service: Kasper's will service your pool once every other week on the scheduled day that we are in your area. **\$115.00/visit + chemicals.**

***** Initial Cleaning of pool is billed at opening vacuum rate. Please see terms and conditions on reverse side.**

Pool Vacuum Service includes:

- vacuum and skim pool (up to one hour) with Kasper's own filter system and skimmer nets
- clean out all baskets and automatic pool cleaner traps
- test pool water for chlorine and pH, treat as necessary with Sunguard chemicals
- visually inspect for clarity and algae-growth, treat as necessary with Sunguard chemicals
- brush pool walls and floor when necessary
- backwash pool filter when necessary
- hose down pool deck when necessary and when garden hose is accessible
- leave written service report each visit

A deposit of \$250 must accompany signed contract. Deposit will be credited to your account on your final maintenance bill.

Vacuum service will begin the week after Memorial Day and end the week before Labor Day.

TERMS AND CONDITIONS

Kasper's Aqua Clear, Inc. of Easton, Pa. (herein after called "Kasper's) agrees to service the swimming pool for the aforementioned owner or lessee who agrees to pay for the services outlined on the front of this contract and in accordance with the terms hereinafter set forth.

The owner or lessee agree to either pre-purchase their season's chemicals from Kasper's or have Kasper's supply their chemicals on a weekly or "as needed" basis. Weekly-supplied chemicals will be billed along with their monthly statement. Kasper's reserves the right not to use chemicals purchased from another source while maintaining a swimming pool covered by this contract. Kasper's shall retain the right to cancel this contract for non-adherence to these terms.

Supplied pool chemicals should be stored in a customer-provided, weather-resistant container (ie. covered, plastic garbage can, Rubbermaid storage box), accessible to our vacuum crew when they arrive. If chemicals are not accessible, new supplies will be provided and separately billed.

*** The owner or lessee understands that this service consists of maintenance only of a clean pool. If your pool was opened by another party, and that party did not do an initial cleaning of your pool, Kasper's will charge our opening vacuum rate of \$115 per hour, and \$47 for each additional ¼ hour, with a minimum charge of \$115 to perform this initial cleaning service. Maintenance rates will apply after this initial cleaning.

This agreement becomes valid upon receipt of \$250.00, to be credited to your account and will be applied to your last vacuum bill.

Maintenance services will be billed monthly with payment due (postmarked) within 10 days from the invoice date. Any account past due shall be subject to cancellation of maintenance contract. Any account past due will be billed a minimum \$5.00 finance charge, which will then accrue at 1-1/2% of the balance due per month (18% annual rate) until account is paid in full.

Should payment on this account be in default and should it be necessary for Kasper's to obtain legal representation and/or institute suit for collection, then owners or lessees agree to pay in addition to the amount due and owing interest thereon and any and all reasonable attorney fees and costs of suit.

This agreement becomes valid upon Kasper's receipt of the original contract copy properly signed by the Pool Owner or Lessee, accompanied with the required deposit and accepted by Kasper's.

Pool systems under contract for maintenance service must be operational first before contract goes into effect. Repairs needed to make a system operational will be separately billed.

If during the life of this contract any pool equipment needs repair or replacement, the customer will be notified as to cost of parts and labor and will be billed separately for such services and replacement parts..

Kasper's can not be held responsible for failure of any pool lines constructed of a material called "flexible PVC", especially if the line in question is an automatic cleaner line under pressures of 30 PSI or more. Flexible PVC, while it may last for many years, will not last as long as rigid, schedule 40 PVC pipe.

Kasper's shall not be held responsible for any damage to lawns, shrubbery, or landscaping caused by the discharging of water from backwashing or cleaning the filtering system.

Kasper's agrees to carry in force and effect Public Liability and Property Damage insurance and Owner's and Contractor's Public Liability and Property Damage Insurance in addition to the Workman's Compensation Insurance required by law.
